A LETTER FROM OUR EXECUTIVE SECRETARY-TREASURER JOSEPH GEIGER

s we approach the summer months, we're turning up the heat on our campaign efforts against Macy's, tax fraud, and unscrupulous contractors looking to exploit workers. We're working with local communities and politicians to strengthen our presence and motivate the public to take action through voting and free speech. Here's a look at some of our recent efforts.

Tax Fraud

Regional Councils across the U.S. and Canada all participated in a campaign against tax fraud. Each campaign culminated in a Stand Against Tax Fraud day on April 15th. Over 1,700 members gathered on the steps of the James A. Farley post office to inform tax payers dropping off their tax returns about the tax fraud that runs rampant throughout New York and bevond. Attorney General Letitia James and District Attorneys from six New York counties spoke about tax subsidies, wage theft, and frequent plovs used by dishonest contractors to cheat workers and New Yorkers.

We all lose when it comes to tax fraud. Taxes pay for our schools, build our bridges, and protect our country. Taxes allow us to retire with dignity and ensure security for our children. We can not allow those who cheat the system to continue to take advantage of hard-working people who are only looking for a way to survive. Our Stand Against Tax Fraud did not end on April 15th. We will continue to fight today, tomorrow, and each day after that.

Macy's

As many of you know, we have been locked in a battle with Macy's.

Macy's is intending to build their New York headquarters in Long Island City, Queens completely non-union. These non-union contractors often pay workers up to 80% less in wages and benefits than union contractors. In the past weeks, the District Council has launched a multi-faceted campaign targeting Macy's. We've taken to the streets and are calling on you to help hurt Macy's where they can feel it - on social media, on Yelp and Google reviews, and in their wallets. Please continue to post to social media using the **#macvssucks** hashtag and urging your family and friends to close their wallets to Macy's. For the most up-to-date information. please visit macyssucks.org. We will continue to

discuss with Macy's the possibility of having our members build phase two.

Town Halls

In an effort to engage the community, the District Council has held several town hall meetings throughout the boroughs. We've had great turnouts for these events and the member response has been overwhelmingly positive. We've been able to educate members on who their elected officials are, how to get involved in community boards, and how to remain active in their communities and neighborhoods, i.e. attending job fairs, civic association meetings, and community board meetings. Most importantly, we've been able to illustrate how member participation leads to increased support for union construction.

Union Participation

Your local union meetings are where you can find out what's going on throughout the Council and take steps to involve yourself. Our members are our power and we at the Council hope you will help us



wield it. To enact change we must stand as one unbreakable force. So attend your meetings, vote, and engage.

Local Law 196 - Deadline Pushed Back

Kindly be advised as per information obtained from the New York City Department of Buildings pertaining to Local Law 196 we are recommending all members who have not graduated from an approved NYSDOL Apprenticeship Program within the past 5 years seeking a Limited Site Safety Training Card to complete an OSHA 30-hour safety training course.

A limited site safety card WILL be required to work on construction sites in NYC starting <u>December 1, 2019</u>.

This training can be accomplished by complying with the following training requirements:

• OSHA 30-Hour Class;

Members may enroll for OSHA 30 at the Carpenters Training Center.

• Members may also take a NYCDOB approved OSHA 30 construction course with voice authentication online from Click Safety. (See link below)


Letter to the Editor

Local Woman Documents Second Avenue Subway Construction for 10 Years

The highly anticipated second avenue subway opened its doors two years ago much to the delight of members and civilians alike, and has been thriving ever since. However, it seems no one loves the new subway station as much as Upper East Side resident Karen Nelson, who, for nearly a decade, documented the station's progress. Taking photos from her window, Karen was, and still is, ecstatic about the construction NYCDCC members did on her block.

"It was the most wonderful gift to have an unobstructed view of this project from my apartment," she said.

Karen archived all her photos on her website <u>theartistupstairs.com/2ndAveSubway.html</u>, which date back to 2008, and even penned a few poems about the subway's construction. While other residents complained about the construction, Karen was impressed and appreciative of the work our members did.

"Some people complained about the noise, but all I could think about was how great of a job everyone was doing and that when they were done we would have this new beautiful station," she said. "They were out there every day no matter the weather. I loved watching them work."

Phase 1 of the second avenue subway opened January 1, 2017, and extended the Q line from 63rd street to 96th street along Manhattan's east side, adding stations at 72nd, 86th, and 96th streets. Phase 2 will extend the Q to 125th street, but no plans have been arranged yet.

A Cultural Exchange

On February 25th, the District Council was proud to welcome representatives from the Japanese Consulate, Japan's Ministry of Land, Infrastructure, Transport and Tourism (MLIT), and Japanese managers of small and medium-sized Japanese construction firms.

The MLIT is working on ways to alleviate a shortage of skilled labor in Japan's construction industry. Currently, there are no trade unions in Japan. The group visited the District Council to research how skilled labor is being developed in local construction markets. EST Joseph Geiger, Vice President Michael Cavanaugh, Training Center Director Peter Bennett, and District Manager Paul Capurso met with the representatives to discuss the union construction industry, training and apprenticeships, and new developments in New York City. After the discussion, the group toured the Training Center to learn what it truly takes to become a union tradesperson. The Japanese representatives were impressed by the complexity and quality of our Training Center and the programs we offer to our members, along with the benefits and quality of life that being a union member brings.







New York City & State Prosecutors, Partners Announce Joint Effort To **Combat Wage Theft In Construction Industry**

New York City and State prosecutors announced criminal charges in multiple cases involving stolen wages, while providing tips on how to spot wage theft and report it to the proper authorities. Enforcement of wage laws will have a great stabilizing effect on the construction industry. Unscrupulous non-union employers evade workers' compensation, unemployment insurance, and basic payroll taxes by knowingly misclassifying workers as "independent contractors," paying in cash off the books, and running other scams. They cost taxpayers billions, hurt honest businesses, and exploit workers.

Wage theft in the construction industry is rampant. This multipronged effort will be a turning point for an industry that is plagued by unscrupulous contractors willing to profit off of the backs of New York families. It is no surprise that the vast majority of wage theft cases involve non-union contractors that prey on a work force that does not have a voice. We will be their voice. "We will continue to advocate for a level playing field in New York's robust construction industry where workers are paid a middle class wage, are properly trained and work on safe job sites," said Joseph Geiger, Executive Secretary-Treasurer of the New York City District Council of Carpenters.



Board of Trustees Appoints New Director of Training for NYCDCC Carpenters Training Center



The Board of Trustees of the New York City District Council of Carpenters (NYCDCC) Apprenticeship, Journeyman Retraining, Educational, and Industry Fund recently appointed Peter Bennett to the position of Director of Training for the NYCDCC Carpenters Training Center (CTC). Mr. Bennett, who has been a member of Millwright Local 740 for over 30 years, joined the CTC as a Millwright Instructor in 2011 and was responsible for coordinating the Millwright Qualification and Apprenticeship Program. In 2013, Mr. Bennett became the Lead Instructor for the CTC, where he has served until his recent advancement to the role of Director of Training.

When asked about his appointment as the Director of Training and his future vision for the CTC, Mr. Bennett said he hopes the training center will be recognized as a "comprehensive learning environment where every member has the right to come and be trained without any sort of infringement."

When reflecting on his upward journey while working at the CTC, Mr. Bennett noted that his favorite course to teach was rigging (CRS), which is one of the hardest courses given at the CTC. "I think that the reward of instructing, especially to the apprentices, is something that I did not expect. Out in the field, I've always tried to mentor apprentices and steer them down the right path," Mr. Bennett said. Mr. Bennett, while fondly recalling his time spent at the CTC as an Instructor, also stated that one of the most rewarding aspects of teaching is witnessing students developing a love for the material.

"People learn in different ways and being able to adapt to people and the ways they learn best is one of things I liked most. When the light bulb goes on and people start teaching themselves, you're no longer in charge of trying to transfer knowledge. They just get enthused and interested and tap into it themselves, and that's what I found to be the most rewarding in any training that I've done."

With his wealth of carpentry knowledge and his passion for teaching, the Board of Trustees of the New York City District Council of Carpenters Apprenticeship, Journeyman Retraining, Educational, and Industry Fund proudly welcomes Peter Bennett as the CTC's new Director of Training.




IT Update: Union Fusion

ARIEL VARGAS | Local 2287



One of the proudest days for any union member is the day they're sworn in – and it was no different for member Ariel Vargas of Local 2287. Ariel's road to union membership was not an easy one, but that makes him all the more grateful for his union card.

Last year, Ariel was working for a nonunion concrete polishing company when he met Business Representative Salvatore Tagliaferro.

"He came up to me and spoke to me about what I do at the company and asked me if I wanted to join the union. I told him yeah I would love to," Ariel said.

Ariel and two of his co-workers met with the leadership at the District Council where they learned more about the District Council and what it would take to get his company to turn union. District Council representatives explained that Ariel would need to get the majority of the workers to sign authorization cards for the union to represent them. Determined to improve their working conditions, Ariel began organizing his co-workers and managed to get 20 out of 22 people to sign.

"We brought cards back to the District Council and everything was well, but the following week I guess somebody threw me under the bus because the manager said he wanted to have a serious talk with me," he said. Ariel's manager discovered his organizing efforts and fired him that same day.

"My manager said for the past year that he was going to give us benefits and he never gave us benefits. He promised but he never committed."

Ariel contacted Business Representative Anthony Lewis who was able to file for Unfair Labor Termination that same month in September 2018. Anthony was also able to set Ariel up with a truck driving job at Classic Carpet while Ariel waited for his NYCDCC apprentice application to go through.

"It gave me something to do," he said. "They helped me out and gave me something to do. I was happy." In January 2019, Ariel's hard work and persistence paid off. He officially began his journey as an apprentice floorcoverer. A few weeks later, Ariel learned that he won his Unfair Labor Termination and received \$5,900 in back pay from the company.

"I felt shocked. I couldn't believe it. I thought nothing was going to happen, but it's just amazing," he said.

Ariel said he feels the most blessed to finally have benefits and steady work. "At my new company, they help everyone," he said. "I'm not by myself anymore. I'm learning a lot with carpet, sweeping, and cleaning. I'm learning a lot in so little time."

Ariel also encourages others who are thinking of organizing to try and be strong and just do it.

"I feel like my life is turning around right now. It started down here and now it's going up little by little."



RETIREE GIFTS HAND-MADE WOOD SCULPTURE OF AN OLD UNION MASCOT

88-year-old retired member Rudolph (Rudy) Ferrari of local 2287 dedicated his life to serving in and advocating for our union. A Bronx native, Rudy was born in 1930 and credits our great union for allowing him to live the fulfilling and stable life he's been able to live and provide for his family. Now, he wants to give back by donating one of his hand-made wooden sculptures.

Rudy said, "You'll only get out of life what you put into it. Look at me, approximately 30 plus years of work, and almost another 30 years retired in a respectable neighborhood in Delray Beach, Florida, and am still receiving pension checks earned from the time I put into my Local NYC International Carpenters Union."

Over the years, Rudy developed his woodworking skills and fell in love with making original wooden figures. To show his appreciation for everything the union has given him, Rudy crafted and donated a oneof-a-kind sculpture of the NYCDCC bulldog mascot.

"I may not go to church every Sunday, but I thank God for my family and the Carpenters Union. If it weren't for them, I don't know where I'd be."



JOHN MOLONEY | Local 157

When did you join the union and how did you become a part of it?

I went to a trade high school called Bergan County Vocational Technical High School in Hackensack, NJ. After I graduated, I was working in carpentry as a house framer and I came home from work one night and was watching the news. They were talking about people lining up to get carpenter union applications, so I came on a Friday night and stayed on line until Monday afternoon to get an application.

What was your favorite jobsite?

Google. The architecture was great.

Some of the things they had us build there they said would take too long to draw, so they would just describe it to us and we would find a way to build it. One time a guy wanted a column that turned into a tree at the top.

How has the union changed since you first joined?

Safety. Job sites are a lot safer. We took a lot of risks back in the day. There are more certifications now too.

How has the union changed your life?

The union is everything to me. I've wanted to be in construction my whole life. My father was a carpenter. He was trained in a technical school in Limerick, Ireland. I was able to raise a family, four children. Three of my sons are in construction.

What would you say to the younger generations of carpenters?

Make yourself valuable. Do a day's work for a day's pay. I always liked leadership roles. I was running work by the time I was 21 and I was a general foreman by the time I was 25. You need to participate, be at your rallies, and be at your union meetings. Know what's going on around you and don't rely on other people to tell you.

DWAYNE WILSON | Local 157



Dwyane Wilson of Local 157 is working to make his community a better place. Earlier this year, Dwayne founded his own nonprofit, Triple Threat Athletics, dedicated to serving youth in his community. The organization is a mentoring and sports agency free for kids and their families that aims to keep kids off the streets by focusing on three key areas of their lives: School, home, and sports. Dwayne had been coaching youth basketball for six years when he noticed that traditional basketball programs were lacking in key areas.

"What I find with just basketball programs is that all they really care about is winning and their reputation and sometimes the kids fall to the wayside," he said. "Triple Threat focuses on everything. If you don't want to play for us, we're still going to help you out by referring you to other teams and we will still be active in your school and your home."

Dwayne said he gets in touch with kids' teachers and goes to teacher parent nights to see where a kid might be struggling in school. The program, which runs entirely on donations, has a partnership with tutoring company Concord to set kids up with tutoring sessions three nights a week for a duration of three months.

"We sit down and find plans for each kid because not all kids are the same," he said. Triple Threat was also recently donated studio time from a local music studio called Brag. "That was one of our first donations. It is huge that we can offer that to our kids," Dwayne said.

Dwayne said the key to a successful program is keeping it small so they can focus on each individual kid to make a large impact on his or her life. If a child is interested in joining, Dwayne said all they must do is show up. To find out if the child is a good fit, Dwayne said they will check the child's the home and school and put them on a probation period for one month to see if they will make the practices and show commitment.

"We want them to wake up, go straight to school, then after school hit practice or hit a tutoring session and by the time they're done with their day, they're just so exhausted they want do it again the next day," Dwayne said. "The main thing is keeping them busy and keeping them off the streets."

Tax Fraud Day of Action Stand Up to Tax Fraud

On April 15th, over 1,300 members of the New York City District Council of Carpenters (NYCDCC) and the New England Regional Council of Carpenters rallied across New York, including at the steps of the James A. Farley Federal Post Office Building in Manhattan, in a show of solidarity to stand up to the rampant issue of tax fraud in the construction industry by dishonest contractors and developers.

District Council members and leadership were joined by New York Attorney General Letitia James, Manhattan District Attorney Cy Vance, Bronx District Attorney Darcel Clark, Brooklyn District Attorney Eric Gonzalez, Richmond District Attorney Michael McMahon, Nassau District Attorney Madeline Singas, Suffolk District Attorney Timothy D. Sini, and Deputy Commissioner for Worker Protection Jim Rogers who addressed rally participants on National Tax Day about the reverberating effect tax fraud and dishonest business practices have on the state and local economy. TwoUBC members, Eddie Perez and Tim Ryan, also addressed the crowd about their experiences with tax fraud in the construction industry. Both members recounted how it affected their ability to find stable work and put food on the table for their families, in addition to the mental and physical turmoil they endured while working for these unscrupulous contractors.

Over the last few months, the District Council launched a campaign to urge New Yorkers to stand up to tax fraud and sign a pledge to support action against dishonest construction contractors.

The pledge received over 520 sign ups. The Stand Up to Tax Fraud campaign was run in conjunction with efforts

led by the United Brotherhood of Carpenters and Joiners of America (UBC) to stop dishonest business practices by unethical contractors who commit tax fraud, wage theft, and insurance fraud.

Efforts by the UBC culminated with member actions across the country on April 15th – National Tax Day. In New York, union members of the NYC District Council of Carpenters and the New England Regional Council of Carpenters turned out for rallies in New York City, Albany, Plattsburgh, Patchogue, Hicksville, Poughkeepsie, New Rochelle, Binghamton, Rochester, Newburgh, Utica, Syracuse and Buffalo to raise public awareness on the issue of tax fraud. Together the Councils represent about 35,000 carpenters in New York State.

"The New York City & Vicinity District Council of Carpenters is proud to stand with the New England Regional Council of Carpenters as we fight against corporate greed and stand up to Tax Fraud," stated Executive Secretary-Treasurer Joseph Geiger. "We have to remember that tax fraud isn't an issue that affects the hardworking members of this union, but it affects every New York resident. Today, we are standing up and fighting back to ensure each and every one of us is treated fairly and not taken advantage of."



Why We're Standing Against Tax Fraud

While you're paying your fair share of taxes, greedy construction employers are cheating the system. Construction tax fraud affects everyone – not just the construction workers on jobsites.

Workers see the effects of these practices immediately in their paychecks, but fraud in the construction industry is far-reaching. When construction employers aren't honest with their books, they steal tax money from the state and federal government. It's not small, and it's intentional.

A minimum of **one in five** contractors commits federal tax fraud. This epidemic costs U.S. taxpayers at least

\$2.6 billion per year.

This means less money for public resources like:

- schools
- infrastructure
- veterans
- police and firefighters
- safety and security for our children

These illegal practices are only becoming more widespread. The lost revenue needs to be made up somehow, meaning the average hardworking tax payer must foot the bill.

This is why we must take a stand against tax fraud!

The role of the Office of the Inspector General is to combat union corruption and serve the membership by acting as an independent and nonpartisan watchdog. We have and will continue to hold our members, employees, and signatory contractors accountable if they violate any of our rules and regulations or engage in misconduct. I have previously discussed that my intent is for the IG's Office to be transparent while maintaining a high degree of independence and integrity. This does not mean that we will not communicate with the members or the Council when necessary. I have committed to providing information on cases and outcomes that the IG's Office has been tasked with investigating. Below are some recent cases handled and the outcomes of those investigations:

Based upon information received from a member and in partnership with the Port Authority of NY/NJ Police Department there was an investigation into fraudulent OSHA cards being circulated. The outcome of this investigation was the arrest of an OSHA instructor who was charged federally for filing false documents.

Acting on information provided by the Organizing Department, an investigation was conducted regarding a member working for a prominent nonunion contractor. The member was charged and ultimately pled guilty prior to his scheduled trial. He was expelled from the union and also received a large monetary fine. This case is an excellent example of the IG's Office partnering with outside law enforcement agencies to address activities taking place within the union which may rise to the level of being criminal in nature. I strongly encourage all of you to contact us if you have information regarding any type of wrongdoing or misconduct. We have recently referred matters to the US Attorney's Office, the Manhattan DA's Office and the Department of Labor for further investigation and possible prosecution. Information provided by our members is handled confidentially and is instrumental in both our internal investigations as well as those referred to other agencies.

We continue to find union members working for nonunion companies. These individuals undercut the union by taking hours from members while benefitting competing nonunion companies. Upon their retirement, these individuals will benefit from the union by collecting their pensions and receiving medical coverage. This office takes these cases very seriously and we are working with the Area Standards Department and Council Representatives to identify individuals and bring them up on charges. If you are aware of these types of situations, please bring it to our attention so that we may investigate to discourage this from continuing. Discussions are also ongoing to determine if these members' pensions and medical coverage can be addressed since they have benefited from your hard work while working directly for your competition.

Every District Council officer, employee and representative has a duty to exercise their authority and to conduct union business in a manner that benefits the union and its membership. This means that personal interests must be set aside whenever business decisions are made and cannot influence actions taken on behalf of the union. While this does not mean District Council representatives cannot benefit from decisions that are beneficial to the organization and the membership, it does mean that personal benefit can never be the driving force for those decisions. Our Code of Ethics, and the law, requires that all actions taken by representatives of the District Council must be exclusively for the benefit of the organization and the membership. This is the guiding principal of the District Council Code of Ethics.

So, what are our responsibilities if we discover that a representative of the District Council has acted improperly, or worse, unlawfully? What if we only suspect misconduct or are unsure of whether the conduct is improper? District Council officers (including local union officers), representatives (including Shop Stewards) and employees (regardless of whether they are members), each have an affirmative duty to report actual or suspected misconduct or violations of the District Council Code of Ethics. Failure to do so can result in disciplinary action, up to and including termination of employment. Rank and file members also have a moral and ethical duty to report suspected misconduct. The union exists for the benefit of the membership and actions that undermine its integrity and reputation harms every member.

There are many ways to report actual or suspected misconduct, or to seek guidance if you are unsure whether an action is proper. Talk to your shop steward, a Council Representative, a local union officer, or an officer of the District Council. You can also contact the Office of the Inspector General, the Chief Compliance Officer or General Counsel. Contact information for each of these individuals is available on the District Council website: **www.nycdistrictcouncil.org**. If you do not feel comfortable reporting to an individual, you can report anonymously through the Office of the Inspector General's hotline – **(855) 822-8477**. There is always someone to talk to or someplace to turn to report concerns and seek guidance.

It is not always easy to report misconduct or seek guidance when you have a concern. But it is always the right thing to do – for you and for your union.

Public Advocate Special Election

With Letitia James being elected to Attorney General, there was a special election for New York City Public Advocate. The Public Advocate is the "watchdog" for New Yorkers, actively advocating for issues across the city and serving as the first in line to succeed the mayor. The Council endorsed Jumaane Williams in the race because of his commitment to advocating for labor and his outspoken support of worker safety. In February, we hosted six political action events to remind members to get out to vote and were successful in boosting member participation. Jumaane Williams was elected to Public Advocate and will have to run again in a primary election in June. We will continue to support him in his campaign!

Definition of Public Works Bill

The Political Action team continues to lobby for the Definition of Public Works bill. This bill creates a public responsibility for public dollars and would clarify how the state defines a public work. We hosted a rally and press conference in the state capital with some of our members, letting elected officials know that this bill is our number one priority. Although the bill did not make it into the budget, we have been able to garner significant support in the legislature and will continue to push it through the Assembly and the Senate.

Tax Fraud Day 2019

The International organized a national Tax Fraud Day of Action on April 15th. We participated by hosting a rally and press conference on the steps of the Farley Post Office in Manhattan. Attorney General Letitia James spoke about tax subsidies and wage theft in New York. District Attorneys from the five boroughs attended as well to speak to the schemes used by unscrupulous contractors to cheat workers and New Yorkers.

Homes for Homecoming Heroes

Our members love nothing more than using their skills to give back to the community. That's why when an opportunity knocked to donate their skills to Homes for Homecoming Heroes, a non-profit organization dedicated to providing affordable houses for returning veterans in Freeport, Long Island, they jumped at the chance.

Earlier this year, Larry Sklar, the director of Homes for Homecoming Heroes, attended a Local 45 meeting to ask our members for help in building his third house on the island. Construction began in early April and members have recently finished working on the rafters and sheathing the roof. Retirees work on the house during the week and a larger crew comes out on Saturdays to knock out the bigger projects.

According to the organization's website, the purchase price of the home is only at the cost of construction with no down payment needed. The goal is to keep the price of each house under \$200,000.

"Being a veteran myself, it's humbling to be a part of a membership that cares for veterans and puts their time, sweat, and blood out there to make a difference to our heroes. While serving, you put your life on hold and often when you get out its extremely hard to catch up. This program makes homeownership a reality at an affordable level and it's because our members are volunteering their time to change a veteran's life," said District Council Representative Michael White.

As members of the District Council, we don't just build because we're told to, we build because we want to. It is our responsibility to get involved within our communities and prove what union carpenters can do!

Experience Modification Rate

Members across locals and jobsites are engaging in Experience Modification Rate (EMR) training to learn about EMR and the importance of zero accidents.

EMR affects how we drive work to union contractors. EMR is the number used to gauge past cost of injuries and future chances of risk. The lower the EMR, the lower insurance premiums will be, **which means more work for union members.** An EMR of 1.0 is considered the industry average. If the EMR is higher than 1.0, insurance premiums will be higher than average. What this means for us is that if an EMR is greater than 1.0, the difference is passed down to you by raising worker premiums. A high EMR raises the cost of union bids.

The good news is that an effective safety program can lower EMR. This is why notices like the one on the right have been posted around job sites and why site leaders have been speaking about the importance of EMR.

Below are several members at work sites explaining the importance of jobsite safety and zero accidents.

Remember: Less accidents for union contractors = More union jobs!

Experience Modification Rate: WHAT YOU NEED TO KNOW



INDUSTRY AVERAGE EMR: 1.0


What does it mean if your business EMR is greater than 1.0?

There has been a worker compensation claim that your insurer has paid. The bad news...Insurers pass this cost along to you by raising worker compensation premiums AND an increased EMR sticks with you for 3 years.



How does high EMR affect cost? Simple: The higher your EMR is, the higher insurance premiums will be. The lower your EMR is, the lower your insurance premiums will be. That is why we need our union contractors to have low EMRs.

Central Park Tower

Pinnacle industries II LLC, Component Assembly Systems, Island Acoustics LLC, Safeway Atlantic LLC, Elite Floor Inc.

Work at 217 W. 57th St. is well underway, and the project is pushing boundaries in more ways than one. The site, also known as Central Park Tower, will soon become the tallest residential building in the United States. Scheduled to be completed in 2020, the project will generate millions of work hours and is an all-union job.

Members are working on installing drywall, framing, flooring, doors, and woodwork. The project also includes 640 workers from the District Council's Provisional Program.

Component Assembly foreman Michael Taveras noted how the project was unique in other ways. Since the building is so tall and supplies are constantly being lifted from floor to floor, vertical traffic makes leaving the jobsite for lunch difficult. As such, the project arranged for workers to have their very own cafeteria on one of the upper floors. It has been dubbed the Wellness Floor. The food is affordable for tradespeople and also allows for them to bring their own lunch to work. The cafeteria is temporary and will be disassembled after the project is complete.







Javits Center Expansion

Component Assembly, EE Cruz, PJP Installers, Roger and Sons

NYCDCC members have been hard at work on the Javits Center expansion. The massive project sits on the north end of the Javits Center and will add an additional 1.2 million square feet to the campus.

Members are working on the foundation of the new structure, as well as drywall, framing, and protection. This project is adding millions of work hours to the benefit funds and once it's complete, the number of hours are expected to grow as the Center welcomes bigger shows and exhibitions.

Member Jay Bracey of local 926 said of the project that he's "happy to be here," and would be "proud to someday say to my grandkids that I worked on this project."

Our 300 Hitters program was developed by the UBC to give our journeymen a broader understanding of our union, the construction industry and our membership's role in shaping the future in the years ahead. This program is a once in a lifetime opportunity for members to tour our state-of-the-art International Training Center (ITC), meet other carpenters from all over the country, and most importantly, learn valuable skills they need to help build a stronger union.

Collaborative Leadership: Building Jobsite Leaders

This three-day program is designed to give jobsite supervisors the tools necessary to improve the overall jobsite, taking it from good to great. Today's leaders need an expanded repertoire of skills and a new mindset to succeed in the increasingly fast-paced, chaotic, and highly competitive industry. This calls for more collaborative-based leadership, and the creation of a partnership culture – one that can harness the knowledge and expertise of all stakeholders. This allows leaders to leverage everyone's best and better compete.

Superintendent Career Training: Plan for the Future

The concept of the Superintendent Career Training (SCT) program is to closely integrate both the technical aspects of construction job site management and the personal/ career development needs of the individual trainee. The Carpenters International Training Fund program utilizes a unique combination of classroom instruction, company-sponsored mentoring and on-the-job training to deliver skill training customized to the individual needs of the sponsoring contractor and the Superintendent/General Foreman trainee.



Next Level Journeymen Program

The Next Level Journeymen program is specifically for returning Journeymen who have exemplified the principles of the UBC Journeymen program. Participants should be members who have successfully completed the UBC Journeymen program and returned back to their job sites to make a measurable impact or stepped up in a leadership role at the Council level. This program is only open to returning Journeymen who have completed the UBC Journeymen program. (Must have completed 300 Hitters Program to be eligible)

3rd Year Apprentice Program: Helping Build Our Industries

The Carpenters Training Center is partnering with the UBC to bring an Apprenticeship Training Program to our eligible apprentices. As the program is run entirely through the training center, you can get more information by contacting their front desk, 212-727-2224.
